Instructions for completion of form

This form must accompany an Application for a Control Body Approval and be completed by all business associates and all executive associates of the Control Body Approval Applicant (section 11(1)(d)) of the *Racing Act 2002*.

The terms “business associate” and “executive associate” are defined in Schedule 3 of the *Racing Act 2002*.

This form must also be completed by a person employed or appointed as an executive officer after a control body is approved (section 42(4)(d)).

Section 313 of the *Racing Act 2002* provides that it is a criminal offence for a person to knowingly make a false statement in this form.

Privacy Statement

Queensland Treasury is collecting information, including personal information, on this form as required by Sections 11(1)(d) and 42(4)(d) of the *Racing Act 2002* (the Act). In accordance with the Act, some personal information may be passed on the following agencies to assist with personal and criminal history searches:

- Queensland Police Service
- Police Departments in other States and Territories
- Crime and Misconduct Commission
- Australian Securities and Investments Commission (ASIC)
- a control body under the *Racing Act 2002* or a control body for a code of racing in another State or Territory

In addition, some of this information will be disclosed to the Minister responsible for Racing. In other circumstances, information on this form will not be disclosed without your authority unless authorised or required by law.

3. I authorise the Chief Executive and any Authorised Person, to take my fingerprints for the purpose of obtaining my criminal history.

I authorise any officer of any police service, law enforcement agency or regulatory body in any jurisdiction to whom a copy of this Consent and Authority is presented, to release to the Chief Executive and any Authorised Person any information or official record of any kind in written, electronic or any other form, which relates to me and is held by the police service, agency or body, including any information relating to my personal and criminal history.
5. I authorise the Chief Executive to disclose my criminal history record and information obtained about me to the Minister responsible for Racing.
6. I indemnify the officers referred to in clause 4 above, the Chief Executive and all Authorised Persons against all actions, suits, proceedings, claims, demands, costs and expenses whatsoever which may be brought against or made upon them or any of them or which may be incurred or become payable by them or any of them by reason of or arising out of or in consequence of this Consent and Authority.
